Entry Requirements:

Each artist may submit up to three works. There is a \$20, non refundable, entry fee per artwork. Quincy Art Center Members receive a \$5 discount per artwork. This signed entry form must be turned in with the artwork. Only works delivered to the Art Center during the designated times or by appointment will be eligible. Works must not exceed 6 feet in any dimension. Works that come in after the judging process will not be eligible for this year's competition. Artists may enter original artwork in any medium. All works must have been completed within the last three years (nothing before November 2022) and must not have been previously exhibited with the Art Center. Collaborative artwork is not eligible. The Quincy Art Center Executive Director, Director of Exhibitions, the Board President, and their family members are ineligible to enter.

Presentation and Content:

All wall-hung work must be framed and/or equipped with hanging devices. All work must be ready to install. Artists must provide any specific hardware or display needs beyond pedestals, nails, and screws. The Art Center reserves the right to install works in any manner deemed necessary for exhibition safety and security. Due to the wide variety of visitors, all entries must be appropriate for all ages. The Art Center reserves the right to refuse any work that does not adhere to any entry, presentation, and content requirements.

Delivery and Pick-Up:

All entries must be delivered and picked up by the artist or their agent during the times listed below. Shipment: Artist may ship artwork for entry. Shipment to and from the Art Center must be covered by the artist and all shipments provided with a return shipping label. Shipped artwork must adhere to all entry requirements. Shipped entries must arrive before judging in order to qualify for this year's competition. An accepted list will be emailed to all artists who entered no later than November 7th at 5 p.m. Artworks left two month past the pick-up date, March 6, 2026, may be disposed of at the Art Center's discretion.

Insurance:

The Art Center will provide fine art insurance on all artwork while in their care through January 17, 2026. Artists are encouraged to secure their own insurance during transport to and from the Art Center.

Sales:

Sales to the public are encouraged. The Art Center will retain a 30% commission per artwork. The sales price must reflect this commission. Sales price and insurance value must be the same.
